

THIS MOTION made by the plaintiffs for summary
judgment as against the defendant John Frederick Cameron,
Litigation Administrator for the Estate of John H. O'Halloran
and for default judgment as against Navarro's and Company
Limited, Navarro's (Bahamas) Limited and Fernando Navarro was
heard this day at Toronto.

ON READING the plaintiffs' motion record and factum, and the factum of John Frederick Cameron, Litigation Administrator for the Estate of John H. O'Halloran, and on hearing the submissions of counsel for the plaintiffs and for John Frederick Cameron, Litigation Administrator for the Estate of John H. O'Halloran,

1. **THIS COURT ORDERS AND ADJUDGES** that the defendant John Frederick Cameron, Litigation Administrator for the Estate of John H. O'Halloran pay to the plaintiff Government of Trinidad and Tobago the sum of \$6,887,234.00, plus pre-judgment interest in the amount of \$633,625.00, on account of the claim with respect to Tesoro.

2. **THIS COURT ORDERS AND ADJUDGES** that the defendants John Frederick Cameron, Litigation Administrator for the Estate of John H. O'Halloran, Navarro's and Company Limited, Navarro's (Bahamas) Limited and Fernando Navarro pay to the plaintiffs Government of Trinidad and Tobago and Trinidad and Tobago (B.W.I.A International) Airways Corporation the sum of \$366,778.00, plus pre-judgment interest in the amount of \$33,743.00, on account of the claim with respect to McDonnell Douglas.

3. **THIS COURT ORDERS AND ADJUDGES** that the defendants John Frederick Cameron, Litigation Administrator for the Estate of John H. O'Halloran pay to the plaintiffs Government of Trinidad and Tobago and Trinidad and Tobago Racing Authority the


sum of \$774,594.00, plus pre-judgment interest in the amount of \$71,262.00, on account of the claim with respect to Sam P. Wallace.

4. **THIS COURT ORDERS** that the defendant John Frederick Cameron, Litigation Administrator for the Estate of John H. O'Halloran pay 95 per cent of the plaintiffs' costs of this motion and of the action to be assessed on a solicitor and client basis.

5. **THIS COURT ORDERS** that the defendants Navarro's and Company Limited, Navarro's (Bahamas) Limited and Fernando Navarro pay 5 per cent of the plaintiffs' costs of this motion and of the action to be assessed on a solicitor and client basis.

THIS JUDGMENT BEARS INTEREST at the rate of 11 per cent per year commencing on June 3, 1991.
